**AMENDMENTS TO THE FIFTH SCHEDULE

**LEGAL NOTICE**

IN EXERCISE of the powers conferred upon the Council of Ministers by Section 114(3) of the East African Community Customs Management Act 2004, the Council of Ministers has amended the Fifth Schedule of the Act as follows:-

Insertion of Paragraph 27 to PART B - GENERAL EXEMPTIONS:

*"Unbleached woven fabrics of a width 80 inches and above imported for manufacture of textile materials".*

*Woven fabrics made from unbleached yarn and which has not been bleached, dyed or printed of a width 80 inches and above provided that:*

- (a) the unbleached woven fabrics are imported by approved Textile Mills in a Partner State for exclusive use in the manufacture of finished fabrics;*
- (b) the imported unbleached woven fabrics shall be subject to customs control and such conditions as the Commissioner shall prescribe in accordance with this Act;*
- (c) the quantities imported shall be subject to such limitations as the Commissioner shall specify;  
and*
- (d) the exemption of import duty on unbleached woven fabrics of width 80 inches and above shall apply for two years from 1<sup>st</sup> March, 2007.*

**This Notice shall be deemed to have come into force on the 1<sup>st</sup> day of March, 2007.**
