AMENDMENTS TO THE FIFTH SCHEDULE (EXEMPTION REGIME) OF  
THE EAC CUSTOMS MANAGEMENT ACT 2004

THE EAST AFRICAN COMMUNITY CUSTOMS  
MANAGEMENT ACT 2004

LEGAL NOTICE

IN EXERCISE of the powers conferred upon the Council of Ministers by Section 114 (3) of the East African Community Customs Management Act 2004, the Council of Ministers has amended the Fifth Schedule of the Act as follows:—

1. Paragraph 15 of Part B is amended by inserting the word “aquaculture,” after the word “horticulture” wherever it appears in the paragraph.
2. Paragraph 22 of Part B is amended by inserting immediately after subparagraph (c), the following new subparagraph—  
  
“(d). *Aluminium cans for diary industry.*”
3. Paragraph 30 of Part B is amended by numbering the first subparagraph as (a) and inserting a new subparagraph (b) to read as follows—  
  
“(b) Spare parts for machinery used in mining imported by licensed mining companies.”

WHEREAS Article 42(2) (1) of the Protocol on the Establishment of the East African Community Customs Union provides that the Council may review annexes to the Protocol on the Establishment of the East African Community Customs Union;


AND WHEREAS the Council has decided to review the East African Community Common External Tariff by splitting its code 4011.20.00 and deleting the additional note on tyres in the Chapter notes that reads "For the purposes of its Code 4011.20.00 tyres of a kind used on buses or lorries shall be having a rime size 17 inches and above".


"For the purpose of its code 4011.20.00 tyres of a kind used on buses or lorries shall be having a rim size 17 inches and above".





## **11<sup>TH</sup> SUMMIT OF HEADS OF STATE**

### **INSTRUMENT OF DELEGATION OF POWERS AND FUNCTIONS**

*(Made under Sections 3, 5, and 6 of the Summit  
(Delegation of Powers and Functions) Act, 2008)*

WHEREAS Article 42(2) of the Protocol on the Establishment of the East African Community Customs Union provides that the Council of Ministers ("the Council") may, with the approval of the Summit of Heads of State ("the Summit"), review the annexes to the Protocol and make such modifications as the Council deems necessary;

AND WHEREAS the Summit (Delegation of Powers and Functions) Act, 2008 provides that the Summit of Heads of State may delegate to the Council the exercise of any power or the performance of any function vested in the Summit by the Treaty for the Establishment of the East African Community;


AND WHEREAS the Council has deemed it necessary to request the Summit to delegate its powers of approval of reviews of the East African Community Common External Tariff and the East African Community Rules of Origin in order to facilitate the smooth operation of customs administration in the East African Community.


WE the undersigned constituting the Summit of Heads of State and pursuant to Sections 4, and 6 of the Summit (Delegation of Powers and Functions), Act 2008 do hereby delegate the powers of the Summit to approve reviews of the East African Community Common External Tariff and East African Community Rules of Origin to the Council subject to the following conditions and qualifications:—


- 1.0 The Council shall report to the Summit the Council's decisions pertaining to any approved reviews of the East African Common External Tariff and the East African Community Rules of Origin;
- 2.0 The Summit shall review this delegation of powers and functions every three years with effect from the date of this delegation;
- 3.0 The approval of the East African Community Common External Tariff and the East African Community Rules of Origin by the Council shall be initiated by the East African Community Sectoral Council on Trade, Industry, Finance and Investment.




