## CLARIFICATIONS/ADDENDUM "SET 2"

Kenya Revenue Authority wishes to inform prospective bidders of the amendments detailed below for the above tender.

No	Query	KRA Response
1.	According to ITT 14.1 you have indicated,Bidders to quote in Kenya Shillings (KES) only" We are requesting for foreign currency to be allowed since we will be importing the Batteries for the UPSs	Bidders are advised that as per the tender document, ITT 14.1, the currency to be quoted is Kenya Shillings. This requirement remains as is.
2.	According to ITT 29.3 you have indicated, "Bidders MUST provide a substantive response for all features irrespective of any attached technical document. Use of Yes, No, tick, Compliant etc. will be considered non-responsive" Kindly clarify what will be considered substantive response.	Bidders are advised to submit comprehensive answers that detail the technical requirements of their proposed product and that are within the minimum requirements of the Authority's specifications.
3.	According to ITT 41.1 you have indicated, "The maximum percentage by which quantities may be increased is: 15%" Please provide further clarification on this statement.	Bidders are advised that 15% of the total contract quantity is the maximum variation that may be allowed for this contract.
4	According to No. iii) you have indicated, "Delivery shall be on a need-by-need basis and commences after signing of the contract. Delivery should be immediately upon receipt of Local Purchase Order of the required items in the list at any given time" Please clarify the total number of batches that will be required and within what timeframe	Bidders are advised that this requirement has been expunged and has been replaced with:  "Delivery shall be one off i.e. The winning bidder shall be expected to supply, deliver and install all the batteries upon receipt of the Local Purchase Order."
5.	Prospective responders for the bid kindly request for a visit to the site, in order to determine the extent of the job in order to come up with a quantitative estimate of the scope of works to be implemented.  Please propose for us a day and time when this can be done.
