1	Clarification on Requirement of three-way agreement with Microsoft (OEM)	Microsoft will provide a copy of the agreement to the bidders. The Microsoft Agreement will form part of the bid documents submitted by the bidders. Any bidder that does not provide the Microsoft agreement will be considered non-Responsive at the mandatory evaluation stage.
2	Is the Microsoft Agreement to be pre-signed in the submissions?	Microsoft Agreement need not be Pre - signed during bid submission. The agreement would be considered during the contracting process.
3	Why is there a requirement for Training Centre accreditation while the scope of the tender is for purchase of licenses?	This requirement provided to allow KRA to consume service credits entitlements for training in Microsoft accredited centres/partners.
4	Which documents apply under technical and financials and should they be uploaded as one or separate documents	The tender is a one envelope bid. The technical and financial proposals are to be uploaded / submitted onto the notes attachment folder.
5	How is the uplift costs catered for?	Bidders are required to provide uplift costs as detailed on Table 5: Price Schedule for Microsoft Products Reinstatement (Uplift) provided on Page 2 of the Addendum Set “2” .
